In accordance with Article 18 from the Law on Associations and Foundations (Official Gazette of RM Nr. 52/2010), the assembly members of the Association for Adult Education LIFELONG LEARNING CENTER Skopje (further on "the Association") at its session held on the 06.03.2013 adopted the following

STATUTE Of the Association for Adult Education LIFELONG LEARNING CENTER Skopje

GENERAL PROVISIONS

Art. 1

The Association for Adult Education LIFELONG LEARNING CENTER Skopje, is an association formed by voluntary association of citizens, to exercise, protect and coordinate their interests and beliefs.

Art. 2

The Association is an independent, non-partisan, non-governmental, multi-ethnic society whose activities will not work for the purpose of making politicalactivities and as such, cannot be a member of a political party.

Art. 3

The Association will exercise its goals, objectives and activities in accordance with the relations regulated by the positive legislation in the Republic of Macedonia and the Statute of the Association.

Art. 4

If the Association makes any profit, it must be used exclusively for supporting and implementing the objectives and activities set forth in the Statute.

Art. 5

The programs and activities of the association cannot be directed to:

- Violent overthrow of the constitutional order of Macedonia
- Encouragement or incitement to military aggression
- Ethnic, racial or religious hatred or intolerance

Art. 6

For achieving the objectives of common interest in the area for which it is established, the Association can take part in Associations and Federations in the country and abroad.

Art. 7

The Association acts on its behalf and for its own accountin legal relations with third parties.

For obligations incurred in legal relations with third parties, the association corresponds with their property and assets.

The members of the association do not correspond with their property for the obligations of the Association.

Art. 8

The Association is represented by the President of the Association.

NAME AND ADDRESS

Art. 9

The name of the Association is:

Association for Adult Education LIFELONG LEARNING CENTER Skopje

The short name of the Association is:

Association LIFELONG LEARNING CENTER Skopje.

The Address of the Association is in Skopje, Meksickastreet Nr.10b.

Art. 10

The Association has its own stamp, seal and sign (logo).

The stamp has a round shape with a written circular text of the full name of the Association.

The seal has a rectangular shape with a written text of the full name of the Association, with space left for the appointment of archival number and date of filing.

The appearance of the sign of the Association is determined by the President of the Association with a separate decision.

The manner of use, storage and number of seals and stamps is determined by decision of the President of the Association.

Art. 11

The work of the Association is public.

The reports to the members and the public are made at a session of the Assembly, on the bulletin board, via the website, through public media and other appropriate manner.

GOALS AND OBJECTIVES

Art. 12

Main objectives of the Association are:

- advancement and promotion of adult education and lifelong learning;
- activities to promote adult education and lifelong learning;
- organization and implementation of various types of forms for adult training;
- implementation of projects in the field of adult education and lifelong learning in the country and region;
- publishing in education;

- raising initiatives for the adoption of normative acts (laws, agreements, etc.);
- activities of common and joint interest;
- research activities in the field of education.

The association will perform the following activities to achieve its objectives:

- 18.12 Publishing of other materials;
- 18.13 Services related to publishing;
- 85.59 Other forms of education, not mentioned elsewhere;
- 85.60 Supporting services in education;
- 94.99 Activities of other organizations based on membership, not mentioned elsewhere.

Priority activity of the Association is 94.99 - Activities of other organizations based on membership, not mentioned elsewhere.

Art. 13

The established goals of the Association are realized according to the program developed by the President, and adopted at a meeting of the assembly of the Association.

RIGHTS AND OBLIGATIONS OF MEMBERS OF THE ASSOCIATION

Art. 14

The membership in the Association is voluntary; after admission the members become a membership card, which must be returned upon termination of membership in the Association. The decision on new members in the Association is made by the President of the Association.

Art. 15

Any individual can be a member of the Association, on voluntary basis, regardless of their age, who accept the aims and objectives of the Association, and the rights and obligations arising from this Statute and other laws of the Association.

Minors may be members of the Association in accordance with the applicable legislation in RM.

Members of the Association may be legal entities under the conditions applicable to the admission of individuals.

Foreign individuals and legal entities may also be members of the Association.

Art. 16

The Association shall keep a registry of members and records of the members of authority.

All data from the previous paragraph of this Article shall be updated at least on an annual basis.

The registry of members of the Association is conducted in accordance with the applicable legislation in the Republic of Macedonia concerning the protection of personal data.

Art. 17

The members of the Association have the following rights and obligations:

- -to pay a membership fee in the Association;
- to participate in the activities of the authorities and bodies of the Association;
- to participate in the activities of the committees in the realization of the activities that will be realized by the Association.

Art. 18

The membership in the Association can be terminated upon personal request of the member with exclusion from the Association.

The Association may exclude a member who is working against the interests of the Association, whose activities may hurt its development and who violates the provisions of the Statute.

The decision on exclusion from the Association is madeby the President of the Association.

AUTHORITIES OF THE ASSOCIATION

Art. 19

Authorities of the Association are:

- Assembly
- President

ASSEMBLY OF THE ASSOCIATION

Art. 20

The Assembly of the Association is its highest authority and consists of all adult members of the Association that carry membership cards and pay the membership fee regularly.

Art. 21

The President of the Association is also the President of the Assembly.

The Assembly meetings are convened by the President.

The Assembly meets at least once a year.

A non-scheduled session of the Assembly may be called upon written request of one third of the members of the Association.

The non-scheduled session of the Assembly is held no later than 30 days after the request has been made.

If the President of the Assembly does not convene a session in 14 days after the request has been made, the session is convened by the initiators.

Art. 22

The Assembly of the Association conducts activities that are defined by the Statute, and in particular it has the following rights and duties:

- adopts the statute, the programs and other acts of the Association;
- performs changes and amendments to the Statute;
- adopts the annual work-report;
- adopts the annual statement report and the financial account reports;
- makes decisions on changes of the goals of the Association;
- makes decisions on the internal organisation and organisational forms of the authorities of the Association;
- elects and dismisses the members of the bodies;
- makes decisions on status changes of the Association;
- decides on joining or disassociation from other associations and membership in the union and international organizations;
- decides on the termination of the Association with a 2/3 majority;
- performs other duties in accordance with the legal regulations, this Act or any other Statute of the Association.

Art. 23

The Assembly resolves and makes decisions by the majority vote of the members present, if more than half the members of the Assembly are present at the session.

The voting is done publicly, and the Assembly may decide to vote secretlyon certain issues.

Art. 24

The Assembly is obligated to maintain the policy of the Association during proposals and the selection of members of the Association, to propose and elect members that with their morals and ethics are eligible for such a choice.

Art. 25

Minutes are taken about the work of the Assembly.

The minutes are recorded by a clerk, who is elected by the members present at the Assembly, separately for each session.

All decisions and conclusions adopted by the Assembly must be recorded in the minutes of the meeting of the Assembly.

The minutes of the session of the Assembly of the Association are signed by the President of the Assembly and the clerk.

The decisions of the Assembly are signed only by the President of the Assembly.

PRESIDENT

Art. 26

The President of the Association presides over the Assembly of the Association.

The mandate of the President is 4 (four) years.

The mandate of the President may end with the resignation of the President.

Art. 27

The President has the following rights and obligations:

- -to represent and stand for the Association in the country and abroad;
- to convene sessions of the Assembly and to preside over them;
- to convene meetings of any body of the Association according to their needs.

MATERIAL AND FINACIAL MATTERS

Art. 28

The Association acquires means of financing from the membership fees, initial deposits, contributions, donations, gifts, bequests, legacies, activities thatmake profits, rents and leases, as well as income from investments, dividends, interest, loans and other income in accordance with the law and statute.

The funds of the association are used to achieve the objectives of the Association defined by the Statute and the program.

Art. 29

The President of the Association is in charge of the execution of the financial plan and program.

TERMINATION OF WORK OF THE ASSOCIATION

Art. 30

The Association terminates its work:

- -if such a decision is reached by the Assembly of the Association, with a 2/3 majority of vote;
- -if the number of members is reduced below the number determined for the establishment;
- -if the Assembly determines that the Association does not meet its goals and objectives;
- -in other cases stipulated by law.

Art. 31

In case of termination of the work of the Association, all property and assets remaining after settlement of all liabilities shall be transferred to the members of the Association in equal parts.

TRANSITIONAL AND FINAL PROVISIONS

Art. 32

This Statute shall enter into force at the date of its adoption.
